MLA Style

The Modern Language Association (MLA) is an organization of teachers and scholars devoted to the study of language and literature. MLA style has been widely adopted by academic journals, schools, and instructors. Since its initial publication, the MLA Style Manual has become the predominant style guide for use in the Humanities in the United States and is commonly used in Canada and other countries worldwide.

Instructions

Entries in the works cited list are arranged in alphabetical order by the last name of the first author, followed by the author's first name. Entries have a hanging indent (second and subsequent lines of citations are indented).

Names: The name of the first author is inverted (last name first), subsequent authors' names are listed as first name followed by last name.

Titles: All English titles are capitalized headline style (capitalize all words except for prepositions and common conjunctions). Please refer the MLA handbook for titles in languages other than English.

Dates: Use the order day month year.

Note: These are only basic examples of the MLA style. More detailed information is available through the MLA Handbook (8th edition) and https://style.mla.org/. In addition, a variety of third-party style guides and web sites can provide further assistance.

Journal Article

Pattern:

[Author Last Name], [Author First/Middle Name], and [Author First/Middle Name] [Author Last Name]. "[Title of the Article]." [Name of the Journal], vol. [Volume Number], no. [Issue Number], [Publication date], pp. [Page number starts]-[ends]. [Database container], doi:[Digital Object Identifier (preferred)] [or URL].

Example:

Crainer, Stuart, and Des Dearlove. "Windfall Economics." *Business Strategy Review*, vol. 14, no. 4, Winter 2003, pp. 68–72. *EBSCOhost*, doi:10.1111/j.2003.00288.x.

Magazine Article

Pattern:

[Author Last Name], [Author First/Middle Name(s)], and [Author First/Middle Name(s)] [Author Last Name]. "[Title of the Article]." [Name of the Magazine], vol. [Volume Number], no. [Issue Number], [Publication Date], pp. [Page number starts]-[ends]. [Database container], [Persistent Link].

Newspaper Article

Pattern:

[Author Last Name], [Author First/Middle Name(s)], and [Author First/Middle Name(s)] [Author Last Name]. "[Title of the Article]." [Name of the Newspaper], [Publication Date], [Edition (if available)], pp. or p. (if only on 1 page) [Page number starts]-[ends]. [Database container], [Persistent Link].

Example:

Robert Solé. "Tenues de Combat." *Le Monde*, 9 Mar. 2010, p. 27. *EBSCOhost*, search.ebscohost.com/login.aspx?direct=true&db=bth&AN=48446701&site=ehost-live&scope=site.

Book Chapter

Pattern:

[Author Last Name], [Author First/Middle Name(s)], and [Author First/Middle Name(s)] [Author Last Name]. "[Title of the Chapter]." [Title of the Book], [contributing statement as applicable] [Author/Editor First/Middle Name(s)] [Author/Editor Last Name], [Publisher Name], [Publication Year], pp. [Page number starts]-[ends].

Example:

Belsky, Janet. "The Research Findings on Gender Issues in Aging Men and Women." *Gender Issues across the Life Cycle*, edited by Barbara Rubin Wainrib, Springer Publishing Co, 1992, pp. 163–71.

E-Book

Pattern:

[Author Last Name], [Author First/Middle Name(s)] [*Title of the E-Book*]. [Publisher Name], [Publication Year]. [*Database container*], [Digital Object identifier or URL].

Example:

Thorbeck, Dewey. *Agricultural Landscapes: Seeing Rural Through Design*. Routledge, 2019. *EBSCOhost*, search.ebscohost.com/login.aspx?direct=true&db=nlebk&AN=2015108&site=ehost-live&scope=site.

Published Conference Paper

Pattern:

[Author Last Name] [Author First/Middle Name(s)] and [Author First/Middle Name(s)] [Author Last Name] (use ', et al.' for 3 or more authors). "[*Title of the Conference Paper*]." [Name of the Conference Proceedings], [Publisher Name], [Publication Date], pp. [Page number starts]-[ends], [Digital Object identifier or URL].

Pattern:

[*Title of the Website*]. [Organization Name] or [Author Last Name] [Author First/Middle Name(s)], [Publication Date], [URL]. Accessed [Access Date].
